











Sample Taping Techniques

Steps	Chevron	U Method	H Method	Single-handed

4	<p>Place adhesive bandage, gauze, or transparent dressing over needle insertion site. Do not tape directly over needle entry site. Do not overtape/overdress to allow easy access to site. Do not place tape completely around the limb which may interfere with blood flow.</p>
